Burn Permit Application

To complete this application, print or type the required information. To type the required information, you must “save as” the document onto your computer. Spokane Regional Clean Air Agency (SRCAA) can not process your request to burn until a completed application is received with the associated fee at least ten (10) working days prior to the first proposed burn date. Any inaccurate information or omissions on the application and/or failure to submit required attachments (e.g. Part A, B, or C), including the required fee, may result in denial of a permit. SRCAA may contact you to arrange an on-site inspection. SRCAA will evaluate your application, which may include information gathered during the site visit(s) and/or obtained from other sources, to determine if requirements for outdoor burning are met. If your application is incomplete, you will be advised of such. A written permit will be issued if your application is approved.

As the applicant and responsible person, you agree to all of the following:

1. Follow and comply with all applicable outdoor burning regulations, including SRCAA, Regulation I, Article VI, Section 6.01, and Ch. 173-425 WAC.
2. If a permit is granted, comply with all conditions contained in the permit. Failure to comply with permit conditions may result in the permit being revoked or suspended.
3. Allow SRCAA, Washington State Department of Ecology, Washington State Department of Natural Resources, or their duly authorized representatives, access to the burning location listed in this application. This includes private roads or access ways under your control that are required to access the burning location for evaluating the permit application and/or for the purpose of investigating conditions specific to the permit issued by SRCAA and applicable regulations.
4. SRCAA may deny an application or revoke a previously issued permit if it is determined that the application contained inaccurate information, or failed to contain pertinent information, which information is deemed to be significant enough to have a bearing on the decision to issue a permit.
5. No permit for outdoor burning shall be granted on the basis of a previous permit history.

Failure to comply with applicable regulations and permit conditions may result in formal enforcement action which includes a civil penalty. I certify that the information provided as part of this application is true and accurate to the best of my knowledge. I have read, understand, and agree to the conditions above.
