Spokane Regional Clean Air Agency Air Quality Report - January 2016





Figure 2: Multi-station 24-hour average PM_{2.5} for January 2016; Spokane County.

The maximum Air Quality Index (AQI) value for January was 71/MODERATE (PM_{2.5}; 24-hour average mass concentration = $21.8 \mu g/m^3$; Figures 1 and 2, Table 1), recorded on the 1st at Spokane-Augusta Ave (Augusta & Fiske). The maximum index value for particulate matter (PM₁₀) was 30 (GOOD; 24-hour average mass concentration = $32 \mu g/m^3$; January 25th; Spokane-Augusta Ave). The maximum AQI value for carbon monoxide was 18 (GOOD; maximum 8-hour concentration = 1.6 ppm; January 1st, 22nd and 23rd; Spokane-3rd & Washington). <u>Figure 1</u>: Air Quality Index (AQI) values for January 2016. The data represent the maximum AQI values across all monitoring stations within Spokane County.

Appendix 1 – National Ambient Air Quality Standards

The Clean Air Act requires EPA to set National Ambient Air Quality Standards (NAAQS) for six common air pollutants, carbon monoxide (CO), lead (Pb), nitrogen dioxide (NO₂), particulate matter (PM₁₀ and PM_{2.5}), ground-level ozone (O₃) and sulfur dioxide (SO₂; Table A-1). These are known as "criteria" pollutants because the US EPA established regulatory limits to concentrations in ambient air using human health or environmentally based criteria. Carbon monoxide, particulate matter and ozone are monitored in Spokane County by the Spokane Regional Clean Air Agency (SRCAA) and the Washington State Department of Ecology (Ecology).

Appendix 2 – Air Quality Index

The Air Quality Index (AQI) is EPA's color-coded tool for communicating daily air quality to the public and can be calculated for any of the criteria pollutants except lead, provided monitoring data are available. An index value above 100 indicates that the concentration of a criteria pollutant exceeded the limit established in the NAAQS. Categories of the AQI are "good" (green, 0-50), "moderate" (yellow, 51-100), "unhealthy for sensitive groups" (orange, 101-150), "unhealthy" (red, 151-200), "very unhealthy" (purple, 201-300) and "hazardous" (maroon, 301-500; Table A-2). The chart below contains new ozone AQI breakpoints that will be effective starting with the 2016 ozone monitoring season.

The carbon monoxide data are maximum 8-hour running averages in parts per million (ppm) and the PM data are 24-hour averages in micrograms per cubic meter of air (μ g/m³). There are no PM_{2.5} or PM₁₀ data for Turnbull National Wildlife Refuge or Spokane Valley-E. Broadway Ave because of equipment malfunctions. The sample filter tape on the BAM at Spokane-Augusta & Fiske came loose on January 2, causing loss of data on the 2nd, 3rd and 4th.
