Research companies prior to hiring

The Washington State Department of Labor and Industries has a helpful publication, "What you should know about hiring a contractor, remodeler, or handyman" available online: <u>Ini.wa.gov/forms-publications/F625-084-000.pdf</u>

In general, be wary of inspectors or contractors who:

- Offer a special price only if you sign today or use other high pressure sales techniques
- Accept only cash and/or require large deposits
- Don't provide a written estimate or provide an estimate that is incomplete
- Want to work on weekends, evenings
- Give you an offer that sounds too good to be true

Asbestos Testing labs

Asbestos surveys include bulk testing to determine if asbestos is present. Samples must be analyzed by a National Voluntary Laboratory Accreditation Program accredited laboratory. The National Institute for Stan dards and Technology (NIST) provides a directory for verifying the NVLAP accreditation status:

There is one Spokane-area asbestos sampling lab: Mountain Laboratories, 509-922-1365.

You can also conduct your own search for accredited sampling laboratories in other areas of Washington and beyond. The state Department of Ecology has an on-line laboratory search (https://apps.ecology.wa.gov/laboratorysearch/SearchAnalyte.aspx) for laboratories capable of asbestos analysis.
