2. Approval of the January 2024, Minutes:

3. Executive Directors Report for January 2024

- a. The Agency awarded IAC (International Aerospace Coatings) the 2024 Clean Air Award for their efforts in improving air quality here in Spokane.
- b. On February 2nd, two of the Agency's vehicles were vandalized and had fuel stolen. This is the second incident of this nature since we have been at our new offices.
- c. The State Auditor has conducted the exit conference with staff and Board member Grover.
- d. On February 7th, The EPA announced new annual NAAQS pm2.5 standards. This will be fully implemented by 2032 and will be based on 2020-2022 data.
- e. The Agency has begun the search for an engineer to replace a retired employee. This may prove challenging. We will advise as we move forward.
- f. We have on the agenda an update to the Advisory Council Policies and Procedures.

- g. On February 29th, the EPA provided an educational update on their proposed LMWC (Large Municipal Waste Combustor) rules. This rule may impact Spokane's WTE.
- h. The low-income woodstove changeout program is slowly getting up to speed as we had to re-write terms of the grant. We currently have a waiting list.
- i. On February 27th, staff participated in the U.S. Attorney's Office for environmental justice community listening session.

4. NAAQS pm 2.5 rule

a. Mark gave a presentation regarding the Final Rule to Strengthen the National Ambient Air Quality Standards for Particulate Matter. Discussion ensued.

5. State Legislative Bills.

a. Scott gave an overview of the upcoming bills going to the state legislature. Discussion ensued.
