- 2. Advisory Council Report Ron Edgar gave an overview of the advisory council meeting. There was an election for vice chair. Ron Edgar received that vote. The topic of discussions covered overburdened communities and wildfire chipping.
- 3. Executive Director's Report for January The Agency has been recognized as a "Platinum" employer by the Spokane CTR program. The City of Spokane Valley has informed us that Councilman Rod Higgins will continue to participate on our Board of Directors. The State Auditor has begun the process of finalizing our last audit. We should get the final letter soon with an exit conference. The Agency has been notified it has received a sub-award for funding concerning wildfire smoke education and outreach. There is a resolution for it during this meeting. The Governor visited the City of Spokane on Jan. 31st to learn more about air quality monitoring in Spokane. The Advisory Council has all positions filled for the current year. The Agency had all staff work from home on January 17th. After the January Board meeting, we finalized a memo of understanding with Spokane County Department of Emergency Management to distribute funds to be used to address organic wildfire debris. The Department of

Ecology released its "Improving Air Quality in Overburdened Communities Highly Impacted by Air Pollution 2023 Report" on December 27<sup>th</sup>. We are still evaluating.
