## WORK SESSION: 9:35 a.m.

- 1. SRCAA Annual Clean Air Award Scott Windsor announced the recipient of the Clean Air Award, Hotstart, and gave an overview of their accomplishments. Terry Judge and Leslie Czernik were presented with the Clean Air Award.
- 2. Municipal Waste Combustor Plan April Westby and Margee Chambers gave background on what a State Plan is, why does EPA approve State Plans, why SRCAA is updating the Municipal Waste Combustor (MWC) State Plan, what the MWC Plan is and what the next steps are. Some discussion ensued.

- 1. Advisory Council Report Ron Edgar gave an overview of the February Advisory Council meeting that consisted of an overview of the Municipal Waste Combustor State Plan, biodiesel/renewable diesel discussion and the upcoming retreat with the Board in May.

The Board needs to decide the content of the retreat. The Board would like to hear about ozone and attainment at the retreat. The Executive Director and Staff continues to operate in accordance with the Governor's and SRHD COVID-19 guidelines. The beginning of February was a difficult time with staff in isolation protocols, but the end of the month was vastly improved. Staff completed Anti-Harassment training online as provided by Enduris. The agency

has begun work on its budget for discussion in upcoming Board meetings. The Executive Director participated in the NACAA Criteria Pollutant February meeting and Ozone control methods in non-attainment areas were discussed. Agency staff is updating the Municipal Waste Combustor plan for the State.
