- 1. Commute Trip Reduction Program Overview Margee Chambers gave an overview of the Commute Trip Reduction (CTR) Program. She explained the history of the program, the different options for commuting, and proposed CTR Program updates.
- 2. Open Public Meetings Act Training Michelle Fossum, Legal Counsel, gave a training on the Open Public Meetings Act & Public Records Act. Discussion ensued by the board regarding what is and isn't a transitory record and possible training for that.

- 1. Advisory Council Report Ron Edgar gave a brief overview of the CTR Update and history on the CTR and topic of electric vs natural gas. Also, the Advisory Council meeting for November and December will be combined and held on December 9th. Discussion ensued on the Marijuana fee structure between the Board and Ron. The Board would like to add this to the agenda for December board meeting.
- **2. Executive Director's Report** The Executive Director stated that there are three Advisory Council positions expiring and need to be filled by the end of the year. We have three candidates that qualify and would like to continue, but SRCAA needs to open the positions to the public as well.

The Executive Director and Staff have selected two final submittals for the Prevent Nonattainment Grant (PNA) application. The first selected was an increase in PM2.5 monitoring sites throughout Spokane, and the second is a dust control plan with Spokane County. SRCAA continues to operate in accordance with the Governor's and SRHD guidelines. Agency Staff has begun the next biennium for the Wood Stove Replacement grant from Ecology. The Agency is considering and would like guidance on incorporating "Juneteenth" as an officially recognized holiday. Staff is analyzing how to potentially accommodate a compressed work week in our operations. It would be voluntary and complement our commitment to our CTR program. Our Air Operating Permits (Title V) billing went out on November. 1 and billing for registered sources is being finalized and updated in our database. The Executive Director participated in numerous Regional and Local meetings online concerning air quality issues.
