

Concise Explanatory Statement

for Amendments to SRCAA Regulation I, Article VI, Section 6.13 and Article X, Section 10.08

Summary of rulemaking and response to comments

Introduction

The purpose of a Concise Explanatory Statement is to:

- Meet the Administrative Procedure Act requirements for agencies to prepare a Concise Explanatory Statement (RCW 34.05.325).
- Provide reasons for adopting the rule.
- Describe any differences between the proposed rule and the adopted rule.
- Provide Spokane Regional Clean Air Agency's (SRCAA) response to written and oral comments.

Reason for Adopting the Regulation

The amendments will clarify requirements, align the 25-year-old surface coating regulation with the federal regulations adopted in 2008 and local New Source Review (NSR) regulations adopted in July 2020. The amendments will close the loop with the NSR regulations by including a low usage threshold in the surface coating regulation. Small, low usage operations below the threshold will be exempt from enclosure and control requirements, reducing the regulatory burden for the small business and help to conserve agency resources by focusing on sources with the potential to have increased emissions or nuisance concerns. The amendments will not change fees or add new requirements for businesses to meet.

Section 6.13(F) Exemptions	Add powder coating that does not exhaust outside to process exemption; update low usage exemption to be based on emissions (potential to emit below 100 lbs/yr and toxics below small quantity emission rate) and exempt from enclosure and control requirements; eliminate hobbyist exemption, add portable surface coating that complies with GOA to enclosure exemption; reorder exemptions list by like exemptions

Section 10.08 Miscellaneous Fees	Update citing of Section 6.13

Differences Between the Proposed Rule and Adopted Rule

RCW 34.05.325(6)(a)(ii) requires SRCAA to describe the differences between the text of the proposed rule as published in the Washington State Register and the text of the rule as adopted, other than editing changes, and stating the reasons for the differences.

No typographical changes were made.

Response to Comments

SRCAA accepted comments between April 4, 2021 and May 6, 2021. A public hearing was held during the May 6, 2021 SRCAA Board of Directors meeting.

Spokane Regional Clean Air Agency (SRCAA) Response:

Thank you for your comment. Official complaints from the public are an important way for Spokane Clean Air to track and respond to air quality problems. Complaints are recorded and tracked via a complaint database. Complaints received by the office are forwarded to the inspection staff for follow-up.

Complaints are public records. Being a public agency, Spokane Clean Air is required by law to provide access to complaints (and contact information) if someone submits a request. If you wish to file an anonymous complaint online, please put "Anonymous" in the Name field and leave the rest of the personal information fields blank. If you wish to call in a complaint and remain anonymous, please let the staff person logging the compliant know. PLEASE NOTE: We are unable to issue odor violations based on anonymous odor complaints. We are also unable to follow-up with the complainant on anonymous complaints, because we do not have the complainants contact information.
